 - a) **Mount Pleasant Traffic Flows** – The following has been received: This issue was raised a couple of years ago and a scheme was proposed to introduce no waiting at any time restrictions (double yellow lines) in this area to remove the parking that was creating the congestion and obstructing the free movement of traffic. These proposals were formally advertised and received a number of objections. In September 2019 we also received correspondence from the local ward members advising that following further discussion with the Parish Council, they wished for the scheme to be abandoned. All of the comments/objections received were subsequently reported and a decision was made to abandon the scheme in its entirety. It is unlikely that the objections/comments received would vary greatly within 2 years so at this time it may be an inappropriate use of limited council funds to propose such measures again. However, if the local ward members supported this being looked at again a scheme could be added to the minor highway work list for consideration for future funding through the AHG. You may therefore wish to discuss this further with the local Cheshire East Councillors for this area and ask them to advise me if they would like this added back to the list.
