## Item No. Detail

# 1822. Apologies for Absence

Apologies were received from Cllrs Shaw, Griffiths, Reynolds and Frost. Also, from CEC Cllr Redstone and PCSO Watson. It was reported that, due to health reasons, Cllr R Griffiths had resigned.

## 1824. Declarations of Interest

## 1825. Minutes of the Meeting of 16<sup>th</sup> November 2022

There had not been a December meeting as it was inquorate. Cllr Harwood proposed, Cllr Brammer seconded and it was unanimously RESOLVED to agree the minutes as true and correct.

## 1826. Matters Arising from the minutes

The following matters were considered:

a) Goal posts for Scholar Green Paying Field – it was felt that a mobile 5-a-side goal would be acceptable, which could be anchored to the ground to prevent theft.

b) Village Halls & Energy Costs – All 3 reports had been received. After a discussion, Cllr Harwood proposed, Cllr Howard seconded and it was unanimously RESOLVED that each village hall would receive a one off special grant to be used for energy saving measures. The Grant committee will consider this further when considering the usual Community Engagement & Development Grant applications.

c) Christmas trees – it was agreed to form a working group to consider future provision.
d) Coronation of King Charles III – it was agreed to consider supporting any activities that communities want to hold, if any.

The meeting agreed to defer the co-options due to the nearness of the local elections.
